Note: Number of new co-opted members can not exceed 1/3rd of current elected community council members

Consideration and approval of nominations / arrangement for election if required

At next meeting (September 27th) consider each nomination separately in the order in which they were received. The community council does not have to co-opt all three members, but can choose to co-opt 1,2,3 or none. The co-options must be supported by 2/3rds of the members present and voting.

Once the outcome of the co-options are known if they do not exceed a third of the elected members no interim election is needed. However, if all three are agreed to be co-opted then the number of co-opted members will exceed a third of elected members (**currently 5**) an interim election will be needed. In this case, the co-opted members will **not** actually be co-opted - they will have to stand in an interim election

Election process ,if required, will be open to the public (not just the three co-opts)

Increase Numbers of Community Council

There is provision to have the community council numbers increased to 12 (*subject to report from Community Council Liaison Officer and approval at Council Executive*) at which stage nominations will be invited to the **7** vacancies. If the number of nominations is less than the number of vacancies then no election is needed, and those nominated will join the CC as elected members.

If valid nominations do exceed the number of vacancies an election will be required

Next Council Executive meeting takes place on 28th September (therefore we would not be able to implement the process – co-opting all three nominees -until our October meeting).

To assist with timing Lorraine McGrorty shall make a request to Cllr Johnstone under **SO 31** provision to request that this be considered outside of the scheduled Council Executive meetings.

If this is successful it would allow the voting and co-opting of all three nominees to be complete at Broxburn Community Council meeting on 27th September.

Treasurers Report

 Treasurer reported that the bank account from previous community council has been located and the authorized signatories has now been increased to three Insurance – confirmed that insurance cover in place for community council meetings

Police Report

- Community Police Officer Andrew Kidd (attending on behalf of Community Police officer David Arnott) outlined contribution that Community Constable shall be able to make at future meetings.
- Police Surgery Vehicle —mobile surgery vehicle will be brought (when available) to East Main Street (coinciding with monthly meetings). This will provide the wider community with a 'scheduled' opportunity to meet the local Community Officer and will also provide (where appropriate) the opportunity to immediately feed issues directly into the concurrent community council meeting
- **Point of contact** whilst any member of the community council is free to contact Community Constable it has been agreed that the point of contact, on behalf of the community council, shall be BCC Secretary
